Lesotho Citizenship (Amendment) Regulations, 2017

Pursuant to section 32 of the Lesotho Citizenship Order 1971¹, I,

LEKHETHO RAKUOANE

Minister responsible for home affairs, make the following regulations:

Citation and commencement

1. These Regulations may be cited as the Lesotho Citizenship (Amendment of Schedule) Regulations, 2017 and shall come into operation on the date of publication in the Gazette.

Amendment of Schedule

2. The Third Schedule to the Lesotho Citizenship Order 1971, is repealed and replaced by the following:

Pursuant to section 36 of the Aliens Control Act 1966¹, I,

Minister responsible for home affairs, make the following regulations:

Citation and commencement

1. These Regulations may be cited as the Aliens Control (Amendment of Schedule) Regulations, 2017 and shall come into operation on the date of publication in the Gazette.

Amendment of Schedule
